

In the past 6 months we've finished the 18 month report,

2 deliverable reports for work package 4 and we visited
two conferences: the International Conference on
Integrated Care and International Health Economics
Association.



18 month report

In January 2017, we were 18 months into the SELFIE project, which is an important deadline for our funder, the EU. At this stage, each Horizon2020 project has to submit a report summarising accomplishments to the EU. The EUR took the lead in writing this report, with the help from each respective work package leader. The 18 month report was approved by the EU, which means that SELFIE can progress as planned.

2 deliverable reports WP4

Another deadline in January 2017 was the WP4 deliverable reports. In this work package we developed the methods to perform comprehensive evaluations of integrated care programmes for multi-morbidity using Multi-Criteria Decision Analysis (MCDA).

- 1. Outcomes report: In the first deliverable report we give an overview of the outcomes that will be included in the MCDA and we describe the methods used to identify and select them.
- 2. MCDA framework development: The second deliverable report starts with a description of MCDA methods in general, followed by the MCDA methods that will be applied in SELFIE.



With the start of the empirical evaluations of 17 integrated care programmes, we have entered a crucial and exciting phase of the SELFIE project. These 17 programmes, spread over 8 countries, include 6 population health management programmes, 5 frail elderly programmes, 3 programmes for persons with problems in multiple life domains besides their health, and 3 palliative care and oncology programmes.

Impact of financing schemes (WP3), weight elicitation questionnaire (WP4), study designs, empirical evaluations (WP5)... We are in the midst of data collection for several work packages!

WP3: Impact of financing/payments schemes and price-setting of integrated chronic care for multi-morbidity

One important goal in SELFIE is to estimate the impact of financing and payment schemes on health care utilisation and expenditures, and on mortality. This research is happening at both the national level and in a combined analysis across SELFIE partners. All SELFIE partners are obtaining data from national databases and the University of Manchester (work package leader) is hard at work to guide the partners in the data analysis. We hope this research answers important questions such as whether integrated payments reduce health care expenditure by substituting use of secondary care with use of primary care.

WP4: Weight elicitation questionnaire

As described in the <u>WP4 Executive summary</u>, the outcomes that will be used in the MCDA are weighted by our 5 P stakeholder groups: Patients, Partners (informal caregivers), Professionals, Payers and Policy makers. The relative importance of the outcomes is measured using a Discrete Choice Experiment method. We are still looking for more respondents! WP5: Study designs and data collection

In the last newsletter we wrote that we were discussing with each programme

whether a comprehensive evaluation can be set up using a Multi-Criteria Decision Analysis (MCDA). We are proud to say that all 17 projects have a study design and are collecting data.
